Effective July 1, 1991, machine permit fees were prorated on a quarterly basis; listed below is the table for permit fees which will be distributed to each jurisdiction.

\$100 for permits effective July 1 through June 30

\$75 for permits effective October 1 through June 30

\$50 for permits effective January 1 through June 30

\$25 for permits effective April 1 through June 30
