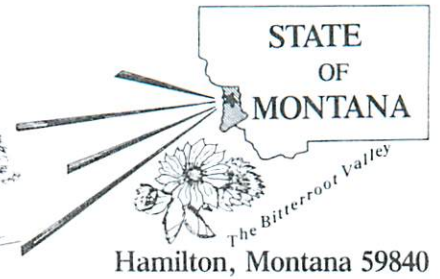
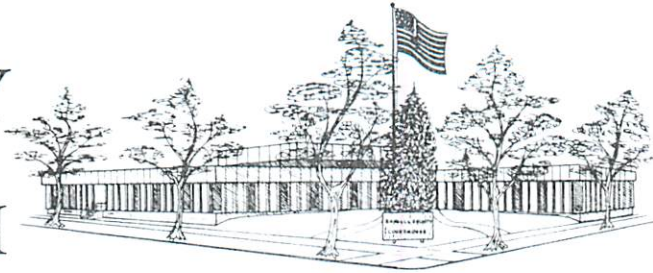

Under the Montana Public Records Act 2-6-1001 et seq., I am requesting an opportunity to obtain copies of the following public information:

- 1) Missoula Public School's 2017 Grant Application for ABE Funds, Including the entire budget and all other details and supplemental materials submitted for the grant.
- 2) Documentation regarding how much of The Missoula Public School's ABE Grant was spent for services in Ravalli County.
- 3) How was the matching grant requirement met for funds spent in Ravalli County?
- 4) What was the Allocation amount from the ABE Funds for Missoula County for 2017-2018?
- 5) What was the Allocation amount from the ABE Funds for Missoula County for 2016-2017?
- 6) What was the Allocation amount from the ABE Funds for Ravalli County for 2017-2018?
- 7) How many HiSET students were served by Missoula Public Schools on location in Ravalli County for 2017-2018?
- 8) How many hours of instruction total were provided by Missoula Public Schools on location in Ravalli County in 2017-2018 under the ABE Grant?
- 9) How many students in Ravalli County received their HiSET from Missoula Public Schools, on location in Ravalli County from the Time of the Award to Missoula of the ABE Grant in 2017 to the present?
- 10) A copy of the Missoula Public Schools Audit for 2017-2018 with all the ABE expenditures highlighted.
- 11) A copy of the Missoula Public Schools Audit for 2017-2018 with all the ABE expenditures examined by their auditors highlighted.

12) All the Minutes and Notes from Montana's Committee to implement the 2014 regulations for the Workforce Investment and Opportunity Act, including a list of names of the committee members with entity affiliation and titles.

If there are any fees for searching or copying these records, please inform me if the cost exceeds \$250.00. This information is not being sought for commercial purpose.

If access to the information I am requesting will take longer than a 'reasonable' amount of time, please contact me with information about when I might expect the requested copies.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
