

RAVALLI COUNTY WEED DISTRICT LANDOWNER ROADSIDE MAINTENANCE PROGRAM

(Voluntary Agreements under §7-22-2153, MCA)

This Landowner Roadside Maintenance Program is established by the Ravalli County Weed District ("Weed District") to provide the following:

- 1. A tool to **educate** landowners in Ravalli County about the spread of noxious weeds along roads and the options for control of those noxious weeds.
- 2. A way to **provide** Weed District approved "Landowner Weed Maintenance Signs" to landowners adjacent to county roads who have entered into a Landowner Weed Maintenance Agreement to manage the noxious weeds along the county roads bordering or running through their land. This **alerts** spray crews that an Agreement exists under §7-22-2153, MCA. **Signs cost \$30.00 per set of two.**

WHAT ARE NOXIOUS WEEDS?

Noxious weeds are non-native plants that compete with desirable plants for nutrients and room to grow. Most noxious weeds are native to Eurasia and have likely entered North America from ship ballast, contaminated food seed, as ornamentals, or in infested hay bales. Natural and cultural controls, such as diseases and intensive grazing, have kept these plants from becoming problems in their native habitat. Since these diseases, insects, and land management practices did not migrate with the plant, noxious weeds in North America can grow virtually unhindered. Noxious weeds do not limit themselves to agricultural areas; they also invade public parks and wilderness lands, County and State roadsides, and small acreages.

Noxious weeds and the seeds of noxious weeds have been declared a common nuisance by the Montana legislature. See §7-22-2115, MCA. Noxious weeds pose a serious threat to Montana's natural resources, and the negative effects include:

- Loss of wildlife habitat and reduced wildlife numbers.
- Reduced crop and farmland production.
- Increased soil erosion and topsoil loss.

- Diminished water quality.
- Reduced livestock grazing capacity.
- Reduced land value and sale potential.
- Diminished waterfowl and fish habitat.

NOXIOUS WEEDS AND COUNTY ROADS

Since noxious weeds are readily transported via man and machines, roadsides provide a perfect corridor from which weeds can be spread. Highways and county roads are identified as a high priority area for noxious weed control in Ravalli County. A good roadside weed control program is essential to check the spread of noxious weeds in these areas.

The Weed District has adopted the following plan for controlling noxious weeds on county road right-of-ways:

- 1. Spot treatment only of noxious weeds in and around populated areas.
- 2. Broadcast treatments, only if needed, for noxious weeds in non-populated areas where environmental considerations are taken into account.
- 3. Use of properly trained operators and herbicide(s) for the control of noxious weeds present.
- 4. Cultural management of noxious weeds in sensitive areas.

VOLUNTARY LANDOWNER ROADSIDE MAINTENANCE AGREEMENTS

The Weed District realizes that landowners may voluntarily seek to enter into an agreement for the management of noxious weeds along county roads bordering or running through their property, and therefore adopts this "Landowner Roadside Weed Maintenance Program" in accordance with §7-22-2153, MCA. Under this Program, any voluntary agreement must, in the Weed District Board's judgment, provide for effective noxious weed management. The agreement must be signed by the participant and be approved by the Weed District board or presiding officer. The Weed District coordinator has drafted a voluntary agreement application form which

contains the minimum requirements for such agreements under Montana law. That form is attached to and made part of this Plan.

If a person would like to participate in a "Landowner Roadside Maintenance Agreement" he or she must fill out the attached application form and submit it to the Weed District Office for consideration. The application will either be approved as submitted, approved with conditions, or not approved. Criteria for non-approval include but are not limited to the following:

- The application does not propose an effective noxious weed management plan that complies with weed control laws and accepted practices.
- b. There is a prior history of noncompliance by the applicant in regard to managing noxious weeds under a previous Landowner Maintenance Program or No Spray Program.
- c. Valid noxious weed complaints have previously been filed against the applicant's property.
- d. The application is detrimental to the County's approved Weed Management Plan.

If a new landowner purchases the property and wants to continue an approved Landowner Noxious Weed Management Plan, that landowner must submit a new Application / Agreement for consideration by the Weed District

If an agreement is approved, the following conditions apply:

- The responsibility for managing noxious weeds on the specified section of right-of-way is transferred from the WEED DISTRICT to the PARTICIPANT signing the agreement. The Weed District will treat noxious weeds up to the posted signs along PARTICIPANT's property borders.
- 2. If the WEED DISTRICT finds that the PARTICIPANT has failed to adhere to the agreement, the BOARD shall issue an order informing the PARTICIPANT that the agreement will be void and that the responsibility for the management of noxious weeds on the right-of-way will revert to the WEED DISTRICT unless the PARTICIPANT complies with the provisions of the agreement within time period specified in the order.
- 3. The Weed District Board is not liable for any injuries or losses suffered by the participant in managing noxious weeds on the county road right-of way. §7-22-2153(2), MCA.

By signing this Application / Agreement, the PARTICIPANT agrees to control the noxious weeds within the boundaries described herein in accordance with the above Noxious Weed Management Plan and the requirements of the Montana County Weed Control Act. The PARTICIPANT further agrees to purchase and post signs approved by the WEED DISTRICT at the above location. Signs must be displayed in a conspicuous manner on all property lines along the road-right-of-way and must be visible from the right-lane flow of traffic.

The PARTICIPANT agrees that he or she has read the "Landowner Roadside Maintenance Program" provided with this Application / Agreement and realizes that the WEED DISTRICT is not liable for any injuries or losses suffered by the participant in managing noxious weeds on the county road right-of way under \$7-22-2153(2), The PARTICIPANT is also aware that weed crews will treat noxious weeds up to the posted signs along participant's property borders.

If approved, this Agreement is valid for three (3) years from date of approval by the Weed District. Before expiration of the three (3) year period, a new signed Application / Agreement must be submitted to the Weed District by the PARTICIPANT. The new Agreement must be approved by the Weed District before the PARTICIPANT may continue his or her Landowner Noxious Weed Management Plan. If a new Application / Agreement is not submitted by expiration of the three (3) year period, management of noxious weeds on the right-of-way will revert to the Weed District.

By October 31st of each year, the PARTICIPANT will submit a written status report to the Weed District Office. A form status report is attached to this Application / Agreement and is also available from the Weed District office or online at www.rcweeds.org. This status report verifies that the appropriate control measures have been fully implemented and completed as agreed by the PARTICIPANT. If the PARTICIPANT does not submit the written status report by October 31st, the Weed District Board will issue an order informing the PARTICIPANT that management of noxious weeds on the right-of-way will be undertaken by the Weed District unless the alternative weed control is verified within thirty (30) days.

If during the term of the Agreement the WEED DISTRICT finds that the PARTICIPANT has failed to adhere to the Agreement, the BOARD shall issue an order informing the PARTICIPANT that the agreement will be void and that the responsibility for the management of noxious weeds on the right-of-way will revert to the WEED DISTRICT unless the PARTICIPANT complies with the provisions of the agreement within time period specified in the order.

BY SUBMITTING THIS APPLICATION / AGREEMENT, THE PARTICIPANT AUTHORIZES THE WEED DISTRICT TO INSPECT THE PROPERTY AS NEEDED FOR REVIEW OF THE APPLICATION AND ENFORCEMENT OF THE AGREEMENT.
